30 hours funded childcare per week for children aged 3 & 4 for the Michaelmas Term 2024

This letter is to provide you with the information you need regarding how 30 hours of funded childcare per week works at Little Amesbury. We are sending this letter to all Baby Room, Pre-Nursery, Nursery and Pre-School parents for awareness and information, whilst conscious that it does not apply to everyone.

If you have already informed us of your eligibility code for 30 hours, the only action required is to renew your code every 3 months and/or inform us on finance@amesburyschool.co.uk if you are told you are no longer eligible.

How it works

We are delighted to offer all eligible 3 & 4 year olds up to 30 hours of funded childcare*, at Amesbury during term time, i.e., it does not apply to holiday club bookings.

Subject to confirmation of eligibility, the funding starts from the term after your child turns 3 years old. The cut off dates for each term, as set out by the government's Early Years funding entitlement programme, are:

- If your child turns 3 years old between **1 September and 31 December**, they will be eligible for 3 & 4 year old funding from the beginning of the Spring Term
- If your child turns 3 years old between **1 January and 31 March**, they will be eligible for 3 & 4 year old funding from the beginning of the Summer Term
- If your child turns 3 years old between **1 April and 31 August**, they will be eligible for 3 & 4 year old funding from the beginning of the Autumn Term

At Amesbury you can apply 3 hours of funded hours to each session your child attends. To claim the full 30 hours your child must attend the setting for five days. See table below for illustration:

Attendance at other Nurseries

Please note that you may claim the funding from several settings (up to the overall maximum of 30 hours per week). When you complete the Surrey County Council Declaration form each term you are eligible, you will be required to list all providers (other than Amesbury, if applicable) where your child is claiming funding and give details of the number of hours you are claiming per week. ***We only claim for the hours your child is at Amesbury.***

To claim

You will need to generate a code initially through the government's childcare choices, **and can apply for the code [here](#)**. **To start benefiting from this funding in September 2024 you must apply for your code and send it to finance@amesburyschool.co.uk by 5 July 2024**. Amesbury will then claim the funding on your behalf and the remaining fees will then be applied to your bill.

Please note that, after having received your code, it is then necessary to renew your code every three months to continue to claim funding. This is applicable even if you haven't yet started to use your code to make a claim, e.g., if you receive your code before 1 June you will need to renew your code before it becomes valid in September. Please note that this is the parents' responsibility.

If you are informed by HMRC that you are no longer eligible to 30 hours funding, please let us know by emailing finance@amesburyschool.co.uk.

Does this funding apply in Reception class if my child is still age 4

The good news is that it does, as the funding continues up to and including the term in which your child turns 5. Please apply for a code as described above.

If I am ineligible for 30 hours does this impact claiming existing 15 hours per week?

No, Surrey County Council provides 15 hours of funded childcare per week for every child aged 3 & 4. A code is not required to claim 15 hours Universal Funding only.

Eligibility Criteria

Firstly, you must meet the criteria, you can check here: [30 hours free childcare - GOV.UK \(www.gov.uk\)](https://www.gov.uk/guidance/30-hours-free-childcare)

Eligibility rules for 30 hours funded childcare an overview:

- Your child must be aged 3 or 4
- Both parents must be working - or the sole parent is working in a lone parent family
- Each parent earns, on average, a weekly minimum equivalent to 16 hours at National Minimum wage or the National Living Wage
- Each parent must have an annual income of less than £100,000
- Parents on zero hour contracts or self-employed are eligible
- One or both parents may be on parental or maternity leave
- One or both parents are on statutory sick pay
- You must live in England
